All that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as a part of Lot No. 34, Section I of Stone Land Company as shown on Plat recorded in Plat Book K, page 277, R.M.C. Office for Greenville County, S. C., and being more particularly described according to survey and Plat by Pickell & Pickell, Engineers, April 3, 1952, as follows:
