NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, about one mile West of the Town of Simpsonville, on South Carolina Highway No. 2 situate on the West side of said highway between the highway and the right-of-way of the Charleston and Western Carolina Railway and having, according to a plat of property of Donald E. and Cathryne A. Davis prepared by Piedmont Engineering. Service May 27, 1948, the following metes and bounds. to-wit:

BEGINNING at an iron pin on the West side of South Carolina Highway No. 2; corner of property of Simpsonville Lumber Company, which Iron Pine is 75 feet from Fred Howard corner, and running thence with the West side of the Highway, S. 2-30 E. 75 feet to an iron pin corner of Simpsonville Lumber Company; thence with line of said property, S. 85-37 W. 200 feet to an iron pin; thence N. 2-30 W. 75 feet to an iron pin; thence with line of property of Simpsonville Lumber Company, N. 85-37 E. 200 feet to the beginning corner.
