"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville. Greenville Township, near the City of Greenville on the south side of Rogers Avenue, being known and designated as Lot No. 21 of the property of B. E. Geer according to a plat thereof recorded in the R. M. C. office for Greenville County in Plat Book G, page 237, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the south side of Rogers Avenue, joint front corner of Lots 21 and 22, and running thence along the south side of Rogers Avenue, N. 83-55 E. 50 feet to an iron pin at the corner of Lot 20; thence along the line of that lot, S. 5-50 E. 150.5 feet to an iron pin on the rear line of Lot No. 9; thence along the rear lines of Lots 9 and 8, S. 83-55 W. 50 feet to an iron pin at the rear corner of Lot 22; thence along the line of that lot, N. 5-50 W. 150.5 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same conveyed to me by E. Inman, Master by deed dated October 15, 1942 and recorded in the R. M. C. office for Greenville County in Deed Vol. 248, at page 99."
