NOW, KNOW ALL MEN, That the Mortgagor; in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as lot No. 9 of White Oak Subdivison of Northside Development Company as shown on a plat prepared by John D. Pellett, Jr. in August 1946, recorded in Plat Book P at Page 121, and described as follows:

"BEGINNING at a stake at the Southwest corner of the intersection of Sewanee Street and White Oak Way (Highway # 291) and running thence with the right-of-way line of Highway # 291, N. 45-23 W. 128.3 feet to a stake, common corner of lots Nos. 8 and 9; thence with the Eastern line of lot No. 8, S. 44-37 W. 130 feet to a stake, common corner of lots Nos. 9 and 10; thence with the line of lot No. 10, S. 63-59 E. 141.5 feet to a stake on the West side of Sewanee Street; thence with the West side of Sewanee Street, N. 33-58 E. 93.6 feet to the point of beginning."
