All that certain piece, parcel or lot of land situate, lying and being in Greenville Township, County and State afbresaid, on the west side of Feurth Avenue in Section 2 of the Judson Mill Village, and being known and designated as lot No. 34 as shown on a plat of Section 2 of the Judson Mill Village, made by Dalton & Neves, Engineers, November, 1939, which plat is recorded in the R.M.C. effice for the County and State aforesaid in plat book K at page 25, and having, according to said plat, the following metes and bounds, te-wit;

BEGINNING at an iron pin at the northwest corner of the intersection of Fourth evenue and Fifth Street, and running thence with the north side of Fifth Street, N.83-53 W. 124 feet to an iron pin on said street; thence with the rear line of lot No. 51, N. 6-07E. 80 feet to an iron pin in line of lot No. 52; thence with line of lots Nos. 52 and 33.
