"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Green ville Township, School District 7-H-1, now within the corporate limits of the City of Greenville, and being known and designated as Lot No. 1, of Block D, of a subdivision known as Fair Heights, as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book F, at page 257, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin at the southwest corner of the intersection of the Laurens Road and Bleckley Avenue, and running thence along the northwest side of Bleckley Avenue, S. 31-20 W. 134.4 feet to an iron pin at the corner of Lot No. 20; thence along the line of Lot No. 20, N. 58-40 W. 92 feet to an iron pin at the rear corner of Lot No. 2; thence along the line of Lot No. 2, N. 48-12 E. 164.9 feet to an iron pin on the southwest side of the Laurens Road; thence along the southwest side of the Laurens Road, S. 30-53 E. 50 feet to the beginning corner; less, however, the strip from the front of the above described lot heretofore conveyed to the Highway Department for widening the Laurens Road; being the same conveyed to me by Dennis Greene and Maggie V. Greene by deed of even date herewith, not yet recorded.
