And if at any time any portion of principal or interest shall be past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole sum of the principal of said note remaining at that time unpaid together with the accrued interest, shall become immediately due and payable, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and if said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity, it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note and mortgage in the hands of an attorney for any legal proceedings; then and in either of such cases the mortgagor promises to pay all costs and expenses including a reasonable attorney's fee, these to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

ALL that lot of land with the buildings and improvements thereon situate on the Southeast side of Augusta Place Street in the City of Greenville, in Greenville County, S. C., being shown as Lot 10 on plat of property of D. W. Cochrane and E.C. Cass, made by R. E. Dalton, Engineer, September, 1924, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "F", at pages 261 and 262, and having according to said plat the following metes and bounds, to wit:
