C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Bates Township, on the Southwest side of Hill Top Drive, near Travelers Rest, being shown and designated as lot No. 14 as shown a plat of Sub-division for Ray E. McAlister, made by Pickell & Pickell Engineers, dated October 15, 1948, and recorded in R. M. C. Office for Greenville County in Plat Book S, page 153 and having the following metes and bounds to wit:-
