NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as let No. 37 as shown on a plat of Central Development Corporation, recorded in Plat Book BB at Pages 22 and 23, and being more particularly described according to a recent survey prepared by C. C. Jones, as follows:

**REGINNING at an iron pin on the Southeast side of Alpine Way, which pin is 255 feet Nertheast of the turnout point of Alpine Way into Dellwood Drive, and is the joint front corner of lets 37 and 38, and running thence with joint line of said lots, S. 50-41 E. 175 feet to iron pin; thence N. 39-19 E. 75 feet to iron pin; thence N. 50-41 W. 175 feet to iron pin in the Southeast side of Alpine Way; thence with Alpine Way, S. 39-19 W. 75 feet to the point of beginning.
