I, William Lee Durham, of Greenville County, SEND GREETINGS:
WHEREAS, I the said William Lee Durham
in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the
full and just sum of Two Thousand, Seven Hundred and No/100 (\$ 2,700.00)
Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in installments of
Twenty-Seven and No/100 (\$ 27.00 ) Dollars upon the first
day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed month-
ly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period
of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the
