

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Dunklin Township, Greenville County, State of South Carolina located on the Morthwest side of the Holliday's Dam Road about one-half of mile Nort east of Holliday's Dam containing one acre more or less and having the following metes and bounds:

BEGINNING at a corner in center of hollicay's Dam Road running 3. 32-20 E. through an iron pin twenty (20) feet from said corner and along acline of F. L. Holliday two numbered and ten (210) feet to an iron pin; thence S. 62-55 W. along a line of land of F. L. Holliday two hundred and ten (210) feet to an ipon pin; thence N. 32-20 W. along a line of land of Amos W oten two hundred and ten (210) feet to a corner in the center of the Holliday's Dam Road line passing through an iron pin off set 23.2 feet from said corner in center of Holliday's Dam Road; thence N. 62-55 E. down the center of Holliday's Dam Road two Hundred and ten (210) feet to the beginning corner; being more fully described in a plat of land entitles G.R. and Margaret M.
