To All Whom These Presents May Concern:

We, Carl A. West and Bobbie B. West SEND GREETINGS:

WHEREAS, we the said Carl A. West and Bobbie B. West

in and by OLF certain promissory note, in writing, of even date with these presents, are well and truly indebted to WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION in the full and just sum of THIRTEEN THOUSAND and no/100--- (\$ 13,000.00) Dollars,

with interest at the rate of six (6 %) per centum per annum, to be repaid in installments of

One Hundred Nine and 71/100--- (\$ 109.71) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid. Said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a ten per cent attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible, as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That we the said Carl A. West and Bobbie B. West

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION, according to the terms of said note, and also in consideration of the further sum of Three Dollars to us the said

Carl A. West and Bobbie B. West in hand well and truly paid by the said WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the North-east side of Oak Forest Drive, near Pleasant Grove Baptist Church, in Chick Springs Township, and being known and designated as lot no. Twenty-one (21) of the John H. Greer property as shown on plat prepared by H. S. Brockman, Registered Surveyor, dated July 16, 1957 and recorded in the R. M. C. Office for said County in Plat Book PP, page 121, and a four foot strip of land on the Northwest side of said lot no. 21, and having the following courses and distances, to-wit: Beginning at a Stake on the Northeast side of Oak Forest Drive at the joint front corner of lots nos. 20 and 21 as shown on said plat, and running thence with the Northeast side of said drive N.38-45 W.100 feet to a Stake, thence N.51-20 E.159 feet to a Stake, thence S.47-35 E.64 feet to an Iron Pin, thence N.49-50 E.21.7 feet to a Stake, thence S.38-45 E.37 feet to a Stake at joint rear corner of said lots nos. 20 and 21, thence with the joint property line of said two lots S.51-15 W.190.4 feet to the beginning point. The above described property was conveyed to Terril H. Vaughn and W. Keith Vaughn by John H. Greer by deed recorded in said office in Deed Book 630, page 244. And being the same property which was conveyed to mortgagors herein by Terril H. Vaughn and W. Keith Vaughn by deed dated this date, which deed will be recorded forthwith in the said office.
