To All Whom These Presents May Concern:

I, M. G. Proffitt, of Greenville County,

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Twenty-Eight Thousand and No/100 - - - -Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of...

Two Hundred and 61/100 - - - - - -200.61) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure extended, will be due and payable_ of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the wholder amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

M. C. office for Greenville County in Plat Book MM, page 39, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northeastern side of Valerie Drive, the joint front corner of Lots 18 and 19, and running thence along the northeastern side of Valerie Drive, N. 37-51 W. 120 feet to an iron pin at the corner of Lot No. 20; thence along the line of that lot, N. 41-25 E. 152 feet to a point on a branch, the joint rear corner of Lots 19 and 20; thence following the meanders of said branch as the line, a traverse line of which is S. 32-20 E. 148.9 feet, to a point at the joint rear corner of Lots Nos. 18 and 19; thence along the joint line of said lots, S. 52-09 W. 135 feet to the beginning corner; being a portion of the property conveyed to me by Carl Duncan, et al., by deed dated May 8, 1958 and recorded in the R.
