THIS MORTGAGE, made this 21st day of January , 1960, between William R. Bray

hereinafter called the mortgagor and SHENANDOAH LIFE INSURANCE COMPANY, with its principal office in the City of Roanoke, Virginia, hereinafter called the mortgagee.

## WITNESSETH:

WHEREAS the mortgagor in and by his certain promissory note in writing, of even date herewith is well and truly indebted to the mortgagee in the full and just sum of <u>Eleven Thousand</u>

Five Hundred and no/100 ---- DOLLARS (\$11,500.00), with interest thereon at the rate set out in said note, due and payable as follows: in equal monthly installments commencing on the 19th day of each successive month thereafter, which payments shall be applicable first to interest and then to principal, with the balance of principal and interest, if not sooner paid, due and payable on the 19th day of January , 1980.
