"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the southern side of East North Street, and being known and designated as the eastern portion of Lot 53 on plat of Overbrook Land Company, recorded in Plat Book E at Page 252, and a 5 foot strip across the rear of said lot formerly being the part of the alley which was heretofore abandoned, and having according to said plat the following metes and bounds, to-wit:
