NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 1 as shown on a plat prepared by Dalton & Neves, Engineers, dated July, 1960, entitled Property of Wooten Corp. of Wilmington recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book UU at page 55, and having according to said plat the following metes and bounds:

BECIMING at an iron pin at the Mortheastern corner of the intersection of Michol Street and Mashington Boulevard, and running thence with the Eastern side of Washington Boulevard N. 16-40 W. 115 feet to an iron pin; thence continuing with the Eastern side of Washington Boulevard M. 31-15 W. 26.8 feet to an iron pin on the joint front corner of Lots Nos. 1 and 2; thence with the line of Lot No. 2 M. 65-0 E. 66 feet to an iron pin; thence S. 17-19 E. 147 feet to an iron pin on the Morthern side of Michol Street; thence with the Northern side of Nichol Street S. 71-22 M. 61.3 feet to the point of beginning.
