## MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Clarence E. Dill and Leona T. Dill (hereinafter referred to as Mortgagor) SEND(S) GREETING.

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND/LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgageo) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eleven Thousand and no/100----

DOLLARS (\$ 11,000.00----), with interest thereon from date at the rate of S1x (6%)--- per centum per annum, said principal and interest to be repaid in monthly instalments of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the Western side of Cahu Drive, shown as Lot 22 on a plat of the Broperty of Clyde Dill, recorded in Plat Book NN at page 192, R. M. C. Office for Greenville County, and being further described according to said plat as follows:

BEGINNING at an iron pin on the Western side of Cahu Drive, joint front corner of Lots 21 and 22, running thence along the joint line of said lots, N. 88-30 W. 216.8 feet to an iron pin in the rear of lot 1; thence along the rear line of lots 1 and 3, N. 4-43 W. 100 feet to an iron pin at the corner of Lot 4; thence along the rear lines of lots 4, 5 and 6, N. 89-22 E. 225 feet to an iron pin on the Western side of Cahu Drive; thence along Cahu Drive, S. 1-30 W. 100 feet to the Beginning corner.
