- (1) That this morrgage shall secure the Morrgages for such further suring se may be advanced hereafter, at the option of the Morrgages, for the payment of taxes, inturence premiums, public assessments, replies or other purposes pursuant to the coverants herein. This morrgage shall also secure the Morrgages for any further, loans, advances, readvances or credits that may be made harsefter to the Morrgager so long as the total indebtedness thus secured close not exceed the original amount shown on the face hereof.
