Slater & Sons, Inc., at Slater, being known and designated as Lot No. 8 of Block E as shown on plat of village of S. Slater & Sons, Inc. made by J. E. Sirrine & Co., Eng., on July 10, 1940, which plat is recorded in the R.M.C.
