TO ALL WHOM THESE PRESENTS MAY CONCERN:

Wayne L. Rich and Emilou Rich (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Fourteen Thousand and no/100-----
DOLLARS (\$14,000.00--- with interest thereon from date at the rate of Six (6%) ---
per centum per annum, said principal and interest to be repaid in monthly installments of

One Hundred Eighteen & no/100- Dollars (\$ 118.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Southwestern side of Colgate Avenue, Paris Mountain Township, being shown and designated as Lot 29 on a plat of College Park, recorded in Plat Book QQ at page 101, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Colgate Avenue, joint corner of Lots 29 and 30, and running thence with the line of Lot 30, S. 29-54 W. 239.6 feet to a pin; thence N. 84-30 W. 125 feet to a pin at the rear corner of Lot 31; thence with the line of Lots 31 and 32, N. 23-57 E. 190.7 feet to an iron pin at rear corner of Lot 28; thence with the line of Lot 28, N. 29-14 E. 146.5 feet to a pin on Colgate Avenue; thence with the Southwest side of Colgate Avenue, S. 44-40 E. 95 feet to a pin; thence continuing S. 36-12 E. 47.5 feet to a point.

Being the same property conveyed to the Mortgagors by deed of H. Z. Jones by deed to be recorded.

Together with all and singular the rights, members, appurtenances, and appurtenances to the same belonging of in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner, it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
