Ed Means as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book J, at pages 186 and 187, being also known and designated as Lot No. 7 of a subdivision of the property of W. M. Morgan and Dolores J. Morgan as shown on plat thereof prepared by Terry T. Dill, Surveyor, April 5 and 6, 1961, and having, according to the last mentioned plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Agnes Street, as relocated, the joint front corner of Lots Nos. 6 and 7, as shown on the Dill plat above mentioned, said pin being 330 feet along Agnes Street from the southeast corner of the intersection of Agnes Street and Emilie Avenue, and running thence along the joint line of said lots, S. 31-40 E. 165 feet to an iron pin on the rear line of Lot No. 11; thence along the rear line of Lots Nos. \$1 and 10, N. 60-17 E. 83 feet to an iron pin at the rear corner of Lot No. 8; thence along the line of that lot, N. 31-40 W. 165 feet to an iron pin on the southeastern side of Agnes Street; thence along the southeastern side of Agnes Street, S. 60-17 W. 83 feet to the beginning corner; being a portion of the property conveyed to us by Paul V.
