Mac Richardson, Surveyor, March, 1960, and recorded in the R. M. C. soffice for Greenville County in Plat Book QQ, at page 6, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northern edge of Ridge Spring Street, the joint front corner of Lots 127 and 128, and running thence along the joint line of said lots, N. 4-24 W. 175 feet to an iron pin in the rear line of Lot 141; thence along the rear lines of Lots 141 and 140, N. 85-36 E. 90 feet to an iron pin at the rear corner of Lot 129; thence along the line of that lot, S. 4-24 E. 175 feet to an iron pin on the northern edge of Ridge Spring Street; thence along the northern edge of Ridge Spring Street, S. 85-36 W. 90 feet to the beginning corner; being the same conveyed to us by Greenville Land Co., Inc. by its deed dated August 7, 1961 and recorded in the R. M. C. office for Greenville County in Deed Vol. 679, at page 443."
