## MORTGAGE

STATE OF SOUTH CAROLINA COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN

(hereinafter referred to as Mortgagor) SEND(S) CREETING:

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further turns for which the Mortgagor may be indebted to the Mortgage at any time for advances made to or for his account by the Mortgage, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, on the Eastern side of the Augusta Road, about six miles south of the City of Greenville, and having the following metes and bounds according to a plat and survey made by C. C. Jones, C. E. July 1954, as follows:

BEGINNING at an iron pin on the Augusta Road, at corner of other property of Alma Eunice Jones, which pin is 300 feet from the intersection of the Augusta Road, and the White Horse Road, and running theme with the Augusta Road, N. 44-53 E. 116.4 feet; thence still with the Augusta Road, N. 44-58 E. 100 feet to an iron pin; at corner of other property of Alma Eunice Hones; thence with the line of the Jones property, S. 20-40 E. 213.1 feet to an iron pin; thence still with the line of Jones property, S. 46-43 W. 31 feet to an iron pin; thence still with line of Jones property, N. 77-12 W. 195 feet to iron pin; thence still with the line of Jones property, N. 32-05 W. 28.7 feet to the point of beginning.

Being the same premises conveyed to the mortgagors by deed recorded in Deed Book 503 at page 514.
