WHEREAS, I/we the aforesaid mortgagor (s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Twelve Thousand, Five Hundred and No/100, 12, 500, 00 ) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

extended, will be due and payable 20. Years after date. NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAYINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

Office for Greenville County in Plat Book RR, at Page 35 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Ikes Road, joint front corner of Lots Nos. 2 and 3; running thence with the joint line of said lots, N. 25-00 W. 175 feet to an iron pin in the rear line of Lot No. 12; thence along the line of Lot No. 12 and continuing along Iine of Lot No. 13, S. 65-00 W: 113 feet, to an iron pin at the joint rear corner of Lots Nos. 3 and 4; thence with the joint line of said lots, S. 29-07 E. 179.4 feet to an iron pin on the northern side of Ikes Road; thence with Ikes Road, N. 60-33 E. 50 feet to a concrete monument; thence continuing with Ikes Road, N. 65-00 E. 50 feet to the beginning corner; being the same property conveyed to me by Robert A.
