All that certain piece, parcel or lot of flind, with all improvements thereon, or hereafter constructed thereon, single, lying and being in the State of South Carolina, County of Greenville, in Oneal Township, about two miles northward from the City of Greer on the north side of the Ballenger Roads at the intersection of said road with the Greer-Oneal Highway, containing 2.77 acres, more or less, and having the following courses and distances, to-wit:

BEGINNING at a point in the center of the Greer-Oneal Road (stake 20 feet from center on bank), corner of W.
