"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the southern

side of Brookwood Drive in the City of Greenville, being shown as all of Lot 60 as shown on plat of Park Hill recorded in Plat Book I at pages 36 and 37 and the major portion of Lot 61 as shown on revised plat of Park Hill recorded in Plat Book J at pages 208 and 209 and also a triangular strip lying to the rear of original Lot 60 and included therein on the revised plat recorded in Plat Book J at pages 208 and 209 and when described as a whole, having the following metes and bounds, to-wit:
