Pacolet River; BEGINNING at a pin in Landrum Road, Bob Campbell's corner and running thence S. 4 W. 5.30 chs to Stake or pin in West edge of road; thence S. 39 1/2 E. 14.76 chs. to pin in place of P. O. gone; Dogwood by pin; thence Tallent line N. 68 E. 16.90 chs. crossing Kill Creek and on to E. Bank of Drain ditch; thence N. 13 1/2 W. 4.75 chs. to pin; Pittman corner; thence N. 68 E. 7.05 chs. to pin; thence N. 40-45 W. 11.05 chs. to stone; thence S. 68-35 W. 14.20 chs to stone; thence N. 89-15 W. 9.46 chs. to pin in road and BEGINNING corner, containing 37 27/100 acres more or less.
