"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, lying on the east side of the Rutherford Road, about $3\frac{1}{2}$ miles northwest of the City of Greer, being all of Lots Nos. 14, 15 and 42 on a plat of the I.D. Bishop property made by H.S. Brockman, Surveyor, dated July 20, 1948, and having the following courses and distances:
