MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, Robert C. Spake and Barbara W. Spake, of Greenville County,

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot #45 of a subdivision known as Coral Ridge, according to a plat prepared by Piedmont Engineering Service, dated March 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book XX, at Page 119, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of Walker Springs Road, joint front corner of Lots 45 and 46, running thence along the joint line of these lots, S. 6-02 W. 178.4 feet to an iron pin in the line of Lot #35; running thence N. 84-41 W. 10 feet to an iron pin; thence N. 83-48 W. 80.0 feet to an iron pin at joint rear corner Lots 44 and 45; running thence along the line of these lots, N. 7-05 E. 179.1 feet to an iron pin on the southern side of Walker Springs Road; thence along the southern side of Walker Springs Road, S. 83-20 E. 86.6 feet to an iron pin, point of beginning; being the same conveyed to us by Mauldin Construction Co. by deed of even date to be recorded herewith."
