"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville in Chick Springs Township, known as Lot No. 22 on plat made by Dalton & Neves in October, 1938, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book I at Page 127, and having the following metes, courses and distances:

BEGINNING at a stake, joint corner of Lots 21 and 22, and running thence 245 feet along newly-cut road S. 86-30 E. to a stake; thence S. 5-0 W., 317 feet to a stake; thence N. 86-20 W., 255.5 feet to a stake, joint corner of Lots Nos. 21 and 22; thence N. 5-0 E., 317.8 feet to initial corner, and containing 1.81 acres, more or less.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
