All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Highland Township, between the old and the new Glassy Mountain Road, containing Seven-tenths (.7) of an acre, more or less, and having the following courses and distances, to-wit: Beginning at an Iron Pin in the new Glassy Mountain Road and running thence N.36-55 E.19 feet to an old Iron Pin on North side of last mentioned road, thence continuing with the same course for a total distance of 159.3 feet to an Iron Pin on South side of the old Glassy Mountain Road, thence with the South side of last mentioned road S.58-32 E.103.5 feet to an old Iron Pin, thence with the South side of last mentioned road S.38-16 E.107.6 feet to an old Iron Pin, thence S.52-43 W.158 feet to the beginning point. Bounded on the North by the old Glassy Mountain Road, on East by lands now or formerly owned by T. P. Farmer and J. B.
