All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Mairview Township, just outside the corporate limits of the Town of Fountain Inn on the West side of Jones Mill Road, known and designated as Lots Nos. 1, 2 and 3 on a Plat designated as "Golden Strip Sub-Div., Frederick W.
