NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, of hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville in Grove ownship, located on Highway No. 29, near Golden Grove, adjoining lands of J. M. Bishop, G. A. Ellis, Tumblin and Highway No. 29 and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the West side of Highway No. 29 at a point $187\frac{1}{2}$ feet Northeast of Fred Tumblin's corner and running thence along line of said Highway, North 31-02 East $187\frac{1}{2}$ feet, more or less, to an iron pin at corner of Floyd J. Massey property; thence along line of that property, North 60 West 250 feet to an iron pin; thence still with line of that property, South $29\frac{1}{4}$ West $158\frac{1}{2}$ feet to an iron pin, rear corner of J.
