order of SOUTHLAND LIFE INSURANCE COMPANY the principal sum of One Hundred Eighty Thousand (\$180,000.00)----- Dollars, with interest thereon from date hereof at the rate of 5-1/2 per cent. per annum, said interest and principal sum to be paid in installments as follows:

Beginning on the 1st day of September, 1965 and on the 1st day of each month thereafter, the sum of Twelve Hundred Thirty-Nine / (\$1,239.00) Dollars, to be applied on the principal and interest of this note until the 1st day of August, 1985, when any balance remaining due on principal, with accrued interest, shall be payable in full. The aforesaid monthly payments of Twelve Hundred Thirty-Nine / (\$1,239.00) Dollars each are to be applied first to interest at the rate of 5-1/2 per cent. per annum on the principal sum of One Hundred Eighty Thousand (\$180,000.00)----- Dollars, or so much thereof as shall from time to time remain unpaid, and the balance of each monthly payment shall be applied on account of principal; all installments of principal and interest of this note being payable at the Home Office of the SOUTHLAND LIFE INSURANCE COMPANY, at Dallas, Texas, in lawful money of the United States of America.
