The above described tract of 8.04 acres, more or less, was subsequently conveyed by William M. Chamblee, Jr. to H. B. Cooper by deed dated April 3, 1957 and recorded in the R. M. C. Office for Greenville County on April 5, 1957 in deed volume 574 at page 298.
