"ALL that certain piece, parcel or lot of land, with all Improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the East side of Craigwood Road and being shown as all of Lot No. 27, in subdivision known as "Section Two, Property of Elizabeth L. Marchant", prepared by Dalton & Neves, Engineers, in July, 1963, which plat is recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book YY at page 145, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Craigwood Road, joint front corner of Lots 26 and 27; thence N. 63-17 E. 298.3 feet to an iron pin; thence with line of property of R. S. Small, S. 22-58 E. 142.7 feet to an iron pin; thence with the line of Lot 28, S. 16-14 W. 285 feet to an iron pin on the East side of Craigwood Road; thence with the line of said road, N. 28-19 W. 150 feet to point of beginning.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
