To All Whom These Presents May Concern:

I, John H. Taylor, Jr., of Greenville County,

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose.

NOW. KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Leyswood Drive near the City of Greenville, being shown as Lot No. 150 on a plat of Section III Wade Hampton Gardens recorded in Plat Book YY at Page 179 and described as follows:

BEGINNING at an iron pin on the southern side of Leyswood Drive at the corner of Lot No. 149 and running thence with the southern side of said drive, S. 74-33 W. 110 feet to an iron pin at the corner of Lot No. 151; thence with the line of said lot, S. 15-27 E. 160 feet to an iron pin in line of Lot No. 155; thence with lines of Lots Nos. 155 and 156, N. 74-33 E. 110 feet to an iron pin at the corner of Lot No. 149; thence with the line of said lot, N. 15-27 W. 160 feet to the beginning corner; being the same conveyed to me by W. G. Raines, et al. by deed dated March 24, 1966, to be recorded herewith.
