To All Whom These Presents May Concern:

I, Myrtle P. O'Brien

hereinafter called

the Mortgagor(s), SEND GREETING:

to be paid in monthly installments of \$ 71.15 commencing on the 11 day of June, 1966
and on the 11 day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not paid sooner, shall be due and payable on the 11 day of May, 1970.

with interest thereon from date at the rate of 6 1/2 per centum per annum, to be computed and paid monthly, as stated above, until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agree(s) to pay all costs and expenses including a reasonable amount as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel, or lot of land lying and being in Glassy Mountain Township, Greenville County, and in the state of South Carolina having the following description:

BEGINNING on a point in the center of the old Sugarloo Road and running thence with said road as the line S. 44.15 W. 342 feet to a point in said road; thence S. 37.15 E. 538 feet to a stake in the branch; thence up said branch N. 57.30 E. 327 feet to a stake; thence N. 36.00 W. 616 feet to the beginning corner, containing four acres and thirty five one hundredths (4.35).
