

## **MORTGAGE**

TO ALL WHOM THESE PRESENTS MAY CONCERN:

DOLLARS (\$ 8,000.00 ), with interest thereon from date at the rate of six and three-fourths per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Chick Springs Township, County of Greenville, State of South Carolina, being known and designated as the Southern half of Lot No. 10 and all of Lot No. 11, Block A, Mayfair Estates, as shown on a plat of said subdivision, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book S at pages 72 and 73, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Mayfair Drive at the joint front corner of Lots Nos. 11 and 12, Block A, and running thence with the line of Lot No. 12 N. 73-51 E. 159 feet to an iron pin; thence N. 10-18 W. 56.5 feet to an iron pin at the joint rear corner of Lots Nos. 10 and 11; thence continuing N. 10-18 W. 25.1 feet to a point in the rear line of Lot No. 10; thence a new line through the center of Lot No. 10 S. 73-51 W. 167 feet, more or less, to a point on the Eastern side of Mayfair Drive in the center of the front line of Lot No. 10; thence with the Eastern side of Mayfair Drive S. 16-09 E. 25 feet to an iron pin at the joint front corner of Lots Nos. 10 and 11; thence continuing with the Eastern side of Mayfair Drive S. 16-09 E. 50 feet to the point of beginning.
