To All Whom These Presents May Concern:

ROBERT E. FISHER AND JOSEPHINE W. FISHER

...(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of Liventy.

Thousand and No/100------(\$ 20,000.00----) Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

therein specified in installments of One Hundred Thirty-Eight and 19/100----- (\$138.19-----) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 25--- years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeasterly side of Fontana Drive, being shown and designated as Lot No. 32, and the adjoining one-half (1/2) of Lot No. 31, on plat of Fontana Forest, recorded in the RMC Office for Greenville County, S. C., in Plat Book "YY", at Page 171, the re-division of Lot No. 31 being shown on plat recorded in said RMC Office in Plat Book "RRR", at Page 3, said Lot No. 32 and portion of Lot No. 31 having the following metes and bounds, to wit:

BEGINNING at an iron pin on the northeasterly side of Fontana Drive, at the joint front corner of Lots Nos. 32 and 33, and running thence with the joint line of said lots N. 42-30 E. 150 feet to an iron pin; running thence with the joint line of Lot No. 25 S. 47-30 E. 100 feet to an iron pin at the joint rear corner of Lots Nos. 32, 31, 26, and 25; running thence with the joint line of Lots Nos. 31 and 26 S. 47-30 E. 52.5 feet to an iron pin in the rear line of Lot No. 31; running thence on a new line through Lot No. 31 S. 47-13 W. 155.4 feet to a new iron pin in front line of Lot No. 31, on the northeasterly side of Fontana Drive; running thence with the northeasterly side of Fontana Drive on a curve, the chord of which is N. 40-35 W., 40 feet to an iron pin, at the front corner of Lots Nos. 31 and 32; thence continuing with the northeasterly side of Fontana Drive N. 47-30 W. 100 feet to the point of BEGINNING.
