for and in consideration of the said debt and sum of money aforesaid, and for better securing the payment thereof to the said Modern Homes Construction Company according to the terms of the said note and also in consideration of the further sum of THREE DOLLARS to me/ks in hand well and truly paid by the said Modern Homes Construction Company at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto Modern Homes Construction Company, its successors and assigns, certain real estate in Greenville County, South Carolina, as follows:

All those pieces, parcels or lots of land in the County of Greenville, State of South Carolina, situate, lying and being on the Southern side of Tugaloo Road (South Carolina Highway No. 414) and being shown as Lots Nos. 1 and 2 of the property of John Daniel and Barbara D. Daniel on plat recorded in Plat Book "GGG" at Page 43 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the Southern side of Tugaloo Road, joint corner of Lot No. 1 and property, now or formerly, of Joseph E. Johnson and running thence with the common line of said properties South 10-15 West 274 feet; thence across the rear line of Lots Nos. 1 and 2 North 78-00 West 300 feet to an iron pin; joint rear corner of Lots Nos 2 and 3; thence with the common line of said Lots North 4-25 West 282 feet to a point on the Southern side of Tugaloo Road; thence with the Southern side of said Road South 77-00 East 175 feet to an iron pin; thence continuing with the Southern side of said Road South 76-39 East 175 feet to an iron pin, the point of beginning.
