"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate, lying and being in thick Springs Township, in the Town of Taylors, beginning at an iron pin on Jones Avenue, at the Southeast corner of Lot No. 21, belonging to Wilbur and Helen Anderson, and running thence with said Lot No. 21, S. 84° 54° W. 142.8 feet to an iron pin on the Southwest corner of Lot No. 21; thence 12° 15 E. 62 feet to an iron pin on Taylor Street; thence N. 84° 50 E. with Taylor Street 134.3 feet to an iron pin on the corner of Taylor Street and Jones Avenue, thence mikk N. 50° 10° 62 feet to the beginning conner in accordance with Plat of Property of Sarah E. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
