All that lot of land in Greenville County, State of South Carolina, on the Eastern side of Seyle Street, near the city of Greenville, being shown as lot No. 51, of Section 4 on a plat of Dunean Mills, made by Peckell and Peckell, and in Plat Book S. at page 173, and described as follows: Beginning at a stake on the Eastern side of Seyle Street, at corner of lot No. 50, and running thence with the line of said lot, S. 64-25 E. 83-8 feet to a stake on a 15 feet alley; thence with the Western side of said alley, S. 85-45 W. 65.9 feet to a stake at corner of lot 52 thence with the line of said lot, N. 58-15 W. 86.1 feet to a stake on Seyle Street; thence with the Eastern side of Seyle Street, N. 27-35 W. 57 feet to the point of beginning.
