"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Prospect Street and being

known and designated as Lot No. 3 on plat of property of C. W. Cason Lumber and Realty Company recorded in the R. M. C. Office for Greenville County in Plat "FFF" at page 151. Said lot fronts 60 feet on the southeastern side of Prospect Street and runs back in parallel lines to a depth of 209 feet and is 60 feet across the rear.
