NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, located about one mile west from Greer, South Carolina, at the northern intersection of Bent Creek Drive and Gregory Drive, and being shown and designated as Lot No. 92 on plat of property entitled "KING ACRES", made by John A. Simmons, Surveyor, dated August 10, 1963, and recorded in Plat Book YY, Page 153, R. M. C. Office for Greenville County, and having the following metes and bounds, to-wit:

BEGINNING on the northern side of Gregory Drive at the joint front corner of Lots Nos. 91 and 92, and running thence N. 26-01 W. 160 feet to iron pin on line of Lot No. 12; thence S. 76-32 W. 65 feet to iron pin on the northeast side of Bent Creek Drive; thence with said Drive, S. 1-08 W. 152.6 feet; thence on a curve, the chord of which is 30.1 feet, S. 60-08 E. to the northern side of Gregory Drive; thence N. 70-53 E. 111.4 feet along Gregory Drive to the beginning corner.
