MORTGAGE OF REAL ESTATE

OLLIE FARNSWORTH ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS.

SETH W. SCRUGGS

(hereinafter referred to as Mortgagor) is well and truly indebted unto

THE PEOPLES NATIONAL BANK

Dollars (\$13,000.00 ) due and payable

six (6) months from date

with interest thereon from date at the rate of eight per centum per annum, to be paid: month

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 7 on a revised plat of Meadowbrook Farms by C. O. Riddle, dated February 1958 and recorded in the RMC Office for Greenville County in Plat Book PP, page 113 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southern side of Loraine Drive at the joint front corner of Lots 6 and 7 and running thence with the southern side of Loraine Drive, N. 85-45 E. 85.6 feet to an iron pin; thence still with Loraine Drive, N. 83-00 E. 9.4 feet to an iron pin at the joint front corner of Lots 7 and 8; thence with the lint line of said lots S 13-01E139 to an iron pin on the bank of a branch; thence with said branch, the center line of said branch being the property line, S. 72-48 W. 106.2 feet to an iron pin on the bank of said branch at the joint rear corner of Lots 6 and 7; thence with the joint line of said Lots, N. 8-44 W. 167.4 feet to an iron pin on the southern edge of Loraine Drive, being the point of beginning.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever tawfully claiming the same or any part thereof.
