TO ALL WHOM THESE PRESENTS MAY CONCERN: Donald Steinman and Hope O. Steinman

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

(\$ 45,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty (30) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 43 of Section 'F' of Subdivision known as GOWER ESTATES as shown by plat thereof prepared by R. K. Campbell and Webb Surveying and Mapping Company dated November, 1965, and recorded in the RMC Office for Greenville County in Plat Book 'JJJ' at Page 99, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast side of Wembley Road at the joint front corners of Lots 42 and 43; and running thence with the line of Lot 42, N. 17-22 E. 336.1 feet to an iron pin; thence N. 63-24 W. 105 feet to an iron pin; thence with the line of Lot No. 44, S. 33-56 W. 185.4 feet to an iron pin on the northeasterly side of Wembley Road; thence with the northeasterly side of said road S. 5-14 E. 82.4 feet to a point; thence continuing with the northeasterly side of Wembley Road S. 9-54 E. 60 feet to a point; thence with the curve of Wembley Road (the chord being S. 30-54 E. 53.1 feet to an iron pin); thence continuing with the curve of Wembley Road (the chord being S. 57-25 E. 67 feet to the beginning corner).
