"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, situate and being on Chestnut Street, and according to a plat made by G. A. Ellis, Surveyor, on April 26, 1946, described as follows:

BEGINNING at an iron pin on Chestnut Street, which point is 55 ft.
