"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the Northwestern corner of the intersection of Pelham Road with Queensway, being shown and designated as Lot No. 2 on a Plat of PELHAM ESTATES, Sec. III, made by Douglas S. Crouch, Engineer, dated February 11, 1965, revised on August 16, 1967, and recorded in the RMC Office for Greenville County, S. C., in Plat Book 4G, page 13, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northern side of Pelham Road at the joint front corners of Lots Nos. 1 and 2 and running thence along the common line of said lots, N. 7-33 W., 200 feet to an iron pin; thence along the common lines of Lots Nos. 2 and 3, N. 68-37 E., 279.4 feet to an iron pin on Queensway; thence along the Western side of Queensway, S. 2-32 E., 113 feet to an iron pin; thence continuing along the Western side of Queensway, S. 0-20 W., 130.8 feet to an iron pin; thence with the curve of the intersection of Queensway with Pelh am Road, the chord of which is S. 41-32 W., 37.7 feet to an iron pin on Pelham Road; thence along the Northern side of Pelham Road, S. 82-27 W., 215 feet to an iron pin, the beginning corner.
