**MORTGAGE**

COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

LAWRENCE C. ASHMORE (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ----- FIFTY THOUSAND AND NO/100----- DOLLARS

(\$ 50,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty (20) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the eastern intersection of Augusta Place and Augusta Road, being known and designated as a part of Lot No. 3 of the original and property of D. J. Cochran and E. C. Case, according to a plat of the same, as shown, the same, September, 1924, together with a triangular strip of land, to-wit: and to-wit: having the following terms and bounds, to-wit:

BEGINS at an iron pin at the intersection of the northwesterly side of Augusta Road and the southerly side of Augusta Place and running thence along the southerly side of Augusta Place, N 20° 34' E, 227.2 feet to an iron pin in the line of property of the said D. J. Cochran and E. C. Case; thence running and running along the line of D. J. Cochran and E. C. Case, S 71° 10' E, 11.7 feet to an iron pin; thence turning and running S 69° 10' E, 111.7 feet to a point; thence turning and running in a southwesterly direction, S 74° 00' E, 100 feet to an iron pin on the northwesterly side of Augusta Road; thence running and running N 65° 32' W, 100 feet to the point of beginning, said property is located in the County of Greenville, State of South Carolina.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
